Director's Desk

Of late, it was felt that the selection pattern for recruiting civil servants needed both structural and functional changes. A perusal of the syllabus makes it crystal clear that one needs to develop an interdisciplinary and holistic approach to comprehend the socio-economic milieu, the new trends in cultural setting and new dimensions of ethical governance with a view to eliminating democracy deficit in India. The rational, ethical and value-based decision making is the new demand. At times, it is said that the neo-liberal concept of governance prefers a minimal state. However, arguably it is not true. Rather an enabling state needs to be created which would structurally shift the government to governance.

The nature of the state is getting transformed from being merely political to socio-economic. Hence, as a regulator and facilitator the state is now responsible for providing a level-playing field both for public and private sectors. The neo-liberal reforms initiated in the 1990s have created new patterns of service delivery based on complex sets of organisations drawn from all of the public, private and voluntary sectors. It suggests that a range of processes including the functional differentiation of the state, the rise of regional blocs & globalisation has left the state increasingly dependent on other organisations for the delivery and success of its policies. In this context, the state can no longer exclusively command others. The new governance, therefore, is characterised by networks in which the state and other organisations depend on each other. Even when the state remains the dominant organisation, it and other members of the network are now interdependent in that they have to exchange resources if they need to achieve

their goals. This interdependence means that the state now has to steer other organisations instead of issuing commands to them. The steering involves a much greater use by the state of diplomacy and related techniques of management.

The democratic legitimacy and credentials of the new governance demand greater people's participation at all the stages of democratic policy processes such as those of deliberation, decision, implementation, evaluation and review.

In this backdrop the Union Public Service Commission (UPSC) has been toiling day and night for making the selection pattern compatible with emerging trends. It could be exemplified by the fact that certain changes were made earlier also in 2000 and 2008 in the syllabus giving it a new orientation.



The Service

The Indian Administrative Service (IAS) is the premier service in India which was formally constituted in 1947. Initially setup as Indian Imperial Service (1893-1946), it offers a reqarding and challenging career.

Sardar Vallabhbhai Patel referred to the Indian Civil Services as the steel frame of the country.

The Civil Services Exam popularly known as IAS Exam is conducted by UPSC (Union Public Service Commission) every year.

UPSC (Union Public Service Commission) is the government agency responsible for selecting the right candidates for this service.

The Civil Services Exam popularly known as IAS Exam is conducted by UPSC (Union Public Service Commission) every year. It is a combined exam to recruit officers into Indian Administrative Service (IAS), Indian Foreign Service (IFS), Indian Police Service (IPS), Indian Revenue Service (IRS), Indian Audit and Accounts Services, Indian Railway Traffic Service (IRTS) and several other Group A & Group B Central services.



PLANOFEXAM

Civil Services examination is a 3-stage exam:

Stage 1: Preliminary Exam

The first stage of the exam – Preliminary (objective) – is a one-day exam, usually conducted around end of May/First week of June.

Stage 2: Main (Written) Exam

The second stage, Mains (subjective), is a five-day exam, conducted around September/ October.

Stage 3: Personality Test

Those who clear Mains face the interview/personality test during the March-May period.

Final Selection

Marks thus obtained by the candidates in the Main Examination (written part as well as interview) determines their final ranking. Candidates are allotted to the various Services keeping in view their ranks in the examination and the preferences expressed by them for the various Services and posts.

- (i) Current events of national and international importance.
- (ii) History of India and Indian National Movement.
- (iii) Indian and World Geography-Physical, Social, Economic Geography of India and the World.
- (iv) Indian Polity and Governance-Constitution, Political System, Panchayati Raj, Public Policy, Rights Issues, etc.
- (v) Economic and Social Development-Sustainable Development, Poverty, Inclusion, Demographics, Social Sector Initiatives, etc.
- (vi) General issues on Environmental ecology, Bio-diversity and Climate Change that do not require subject specialization.

General Studies Paper 2 (CSAT) Qualifying

- (i) Comprehension;
- (ii) Interpersonal skills including communication skills; Logical reasoning and analytical ability;
- (iii) Decision making and problem solving; General mental ability;
- (iv) Basic numeracy (numbers and their relations, orders of magnitude, etc.) (Class X level)
- (v) Data interpretation (charts, graphs, tables, data sufficiency etc. Class X level)
- Note 1 :Paper-II of the Civil Services (Preliminary) Examination is a qualifying paper with minimum qualifying marks fixed at 33%.
- Note 2: The questions are of multiple choice, objective type.
- Note 3: It is mandatory for the candidate to appear in both the Papers of Civil Services (Prelim) Examination for the purpose of evaluation. Therefore a candidate will be disqualified in case he/she does not appear in both the papers of Civil Services (Prelim) Examination.

Main Examination

Qualifying Papers on Indian Languages and English

The aim of the paper is to test the candidates' ability to read and understand serious discursive prose, and to express his ideas clearly and correctly, in English and Indian language concerned. The pattern of questions would be broadly as follows:

- Comprehension of given passage
- Short translation from English to Indian languages.

Indian Languages

Comprehension of given passage Usage and Short Translation from English to Indian Language and vice-versa.

Note 1: The papers on Indian Languages and English will be of Matriculation or equivalent standard and will be of qualifying nature only. The marks obtained in these papers will not be counted for ranking.

Note 2: The candidates will have to answer the English and Indian Languages papers in English and the respective Indian language (except where translation is involved).

SYLLABUS

Paper-I: Essay

Candidates may be required to write essays on multiple topics. They will be expected to keep closely to the subject of the essay to arrange their ideas in orderly fashion, and to write concisely. Credit will be given for effective and exact expression.

Indian Heritage and Culture, History and Geography of the World and Society

- 10) Distribution of key natural resources across the world (including South Asia and the Indian sub-continent); factors responsible for the location of primary, secondary, and tertiary sector industries in various parts of the world (including India).
- 11) Important Geophysical phenomena such as earthquakes, Tsunami, Volcanic activity, cyclone etc., geographical features and their location-changes in critical geographical features (including water-bodies and ice-caps) and in flora and fauna and the effects of such changes.

Questions may utilise the case study approach to determine these aspects. The following broad areas will be covered:

- 1) Ethics and Human Interface: Essence, determinants and consequences of Ethics in-human actions; dimensions of ethics; ethics in private and public relationships. Human Values lessons from the lives and teachings of great leaders, reformers and administrators; role of family society and educational institutions in inculcating values.
- 2) Attitude: content, structure, function; its influence and relation with thought and behaviour; moral and political attitudes; social influence and persuasion.
- 3) Aptitude and foundational values for Civil Service, integrity, impartiality and non-partisanship, objectivity, dedication to public service, empathy, tolerance and compassion towards the weaker-sections.
- 4) Emotional intelligence-concepts, and their utilities and application in administration and governance.
- 5) Contributions of moral thinkers and philosophers from India and world.
- 6) Public/Civil service values and Ethics in Public administration: Status and problems; ethical concerns and dilemmas in government and private institutions; laws, rules, regulations and conscience as sources of ethical guidance; accountability and ethical governance; strengthening of ethical and moral values in governance; ethical issues in international relations and funding; corporate governance.
- 7) Probity in Governance: Concept of public service; Philosophical basis of governance and probity; Information sharing and transparency in government, Right to Information, Codes of Ethics, Codes of Conduct, Citizen's Charters, Work culture, Quality of service delivery, Utilization of public funds, challenges of corruption.
- 8) Case Studies on above issues.


